EDUCATIONAL QUALIFICATIONS:-

For Senior Resident: - MBBS Degree from MCI recognized university with P.G. M.D/ Diploma/DNB qualification in respective specialty and the candidate must not have completed three years of Senior residency in any govt. recognized institution including regular and adhoc period. If such candidates are not available in specialty, others without post graduate qualification along with 03 years of experience in concerned specialty may be considered for the post and will be appointed on adhoc basis for 89 days or till the regular incumbent joins which ever is earlier. Registration of PG/Diploma/DNB in specialty with Delhi Medical Council is compulsory.

AGE LIMIT:-For S.R. -37 years for General, 42 years for SC/ST and 37 years for OBC(Delhi) candidates (as on date of interview).

<u>Relaxations for – Reservation to Handicapped candidates shall be given as per rules.</u>

EMOULUMENTS:-

Tenure:-

For Senior Resident (regular basis):- The tenure of senior residents is for a period of three years including any service rendered as Senior Residency earlier on adhoc/regular basis in any govt. recognized government institution. The appointment will be initially for a period of one year that can be extended

rther up to a period of three years subject to satisfactory performance work and conduct report from concerned HOD.

Firstly, the list containing the name of fresh candidates would be exhausted for appointment as

Sr. Residents and second list would be used only after that.

All Senior Residents appointments from second list will be for one year only. It would not be renewable after one year.
