Vice President	35	No such Maximum age limit	6 years	The Vice President of India is the ex-officio chairman of Rajya Sabha. He gets a salary of Rs. 1,25,000 per month as chairman of Rajya Sabha not as a Vice President
Chief Justice of India	No Minimum age limit	65	No fixed tenure but remains in the office up to age of 65 years	Chief Justice of India shall be appointed by the President and is eligible to a monthly salary of Rs. 90,000.
Other Judges of Supreme Court	No Minimum age limit	65	No fixed tenure but remains in the office up to age of 65 years	The Supreme Court Judges are appointed by the President
Attorney General of India	No Minimum age limit	65	No fixed tenure	Attorney General of India is appointed by the President
Lok Sabha Member	25	No Maximum age limit	5 years	Monthly Salary - Rs. 50,000
Rajya Sabha Member	30	No Maximum age limit	6 years	Monthly Salary - Rs. 50,000
Lok Sabha Speaker	25	No Maximum age limit	5 years	Serves during the life of Lok Sabha (maximum 5 yrs)

Lok Sabha Deputy Speaker	25	No Maximum age limit	5 years	He/she can be elected among the members of Lok Sabha
Governor	35	No Maximum age limit	5 years	Monthly Salary – Rs. 1, 10,000.
CAG of India	No Minimum age limit	65	6 years or up to age of 65 years	CAG of India shall be appointed by the President
Chief Minister	25	No Maximum age limit	5 years	Salary varies as per the state Govt income
MLA	25	No Maximum age limit	5 years	The monthly salary for an MLA varies from one state to another state
MLC	30	No Maximum age limit	6 years	This is also called as upper house of the state.
Chief Justice of High Courts	No Minimum age limit	62	No fixed tenure but remains in the office up to age of 62 years	The Chief Judge Shall be appointed by President of the India in consultation with the State Governor
Other Judges of High Court	No Minimum age limit	62	No fixed tenure but remains in the office up to age of 62 years	The Judge of the High Court shall be Appointed by the President of India after consultation with the Chief justice of the High Court

Chairman UPSC	No Minimum age limit	65	6 years or up to age of 65 years which is earlier	The Chairman appointed by the President of India
Other Members of UPSC	No Minimum age limit	65	6 years or up to age of 65 years which is earlier	The members of UPSC appointed by the President of India
Chief Election Commissioner of India	No Minimum age limit	65	6 years or up to age of 65 years which is earlier	The CEC of India shall be appointed by the President
